SUBJECT: **Resolution confirming Mayor Bliss' appointment of Mayor-Elect David LaGrand to the Grand Valley Metropolitan Council, Mobile GR Commission, Interurban Transit Partnership, Downtown Development Authority, Monroe North Tax Increment Finance Authority, and Waste to Energy Advisory Committee**

A resolution has been prepared to confirm Mayor Bliss' appointment of Mayor-Elect David LaGrand to the following boards and commissions:

The Grand Valley Metropolitan Council for the remainder of a two year term ending September 30, 2025; the Mobile GR Commission for a three-year term ending January 3, 2028; the Interurban Transit Partnership Board for a two year term ending December 31, 2026; the Downtown Development Authority for a four-year term ending January 1, 2029; the Monroe North Tax Increment Finance Authority for the remainder of a three-year term ending December 31, 2025; and the Waste to Energy Advisory Committee for a one-year term ending January 5, 2026.

After these appointments, there will be no vacancies on the Grand Valley Metropolitan Council, Mobile GR Commission, Interurban Transit Partnership board, Downtown Development Authority, Monroe North Tax Increment Finance Authority, or the Waste to Energy Advisory Committee. Board demographic compositions are attached.

Your COMMITTEE ON APPOINTMENTS recommends the adoption of the following resolution confirming Mayor Bliss' appointment of Mayor-Elect David LaGrand to the Grand Valley Metropolitan Council, Mobile GR Commission, Interurban Transit Partnership, Downtown Development Authority, Monroe North Tax Increment Finance Authority, and Waste to Energy Advisory Committee.

RESOLVED:

1. That Mayor Bliss' appointment of Mayor-Elect David LaGrand to the Grand Valley Metropolitan Council for the remainder of a two-year term ending September 30, 2025, be confirmed; and
2. That Mayor Bliss' appointment of Mayor-Elect David LaGrand to the Mobile GR Commission for a three-year term ending January 3, 2028, be confirmed; and
3. That Mayor Bliss' appointment of Mayor-Elect David LaGrand to the Interurban Transit Partnership Board for a two-year term ending December 31, 2026, be confirmed; and
4. That Mayor Bliss' appointment of Mayor-Elect David LaGrand to the Downtown Development Authority for a four-year term ending January 1, 2029, be confirmed; and
5. That Mayor Bliss' appointment of Mayor-Elect David LaGrand to the Monroe North Tax Increment Finance Authority for the remainder of a three-year term ending December 31, 2025, be confirmed; and
6. That Mayor Bliss' appointment of Mayor-Elect David LaGrand to the Waste to Energy Advisory Committee for a one-year term ending January 5, 2026, be confirmed.
