SUBJECT: **Resolution scheduling a September 24, 2024, public hearing to consider past performance detailed in the Federal Fiscal Year (FFY) 2023 Consolidated Annual Performance and Evaluation Report and future needs of housing and community development programs**

Attached is a resolution scheduling a public hearing on Tuesday, September 24, 2024, at 7:00 p.m. to provide citizens the opportunity to comment on past performance of housing and community development programs. The hearing also will offer citizens the opportunity to identify community needs to be addressed by future programs. Written comments will be accepted from September 9, 2024, through September 25, 2024.

Program Performance. Citizens are invited to comment on the draft copy of the FFY 2023 Consolidated Annual Performance and Evaluation Report (CAPER). The CAPER contains fiscal and program performance information for activities carried out from July 1, 2023, through June 30, 2024, with Community Development Block Grant (CDBG), HOME Investment Partnerships (HOME), and Emergency Solutions Grants (ESG) program funds. This time period represents the third program year of the FY 2022-2026 Regional Consolidated Housing and Community Development Plan.

The report will be available for public review by September 9, 2024, at www.grcd.info and in the Community Development Department, City Hall, Suite 460, from 8:00 a.m. to 5:00 p.m.


Community Needs. Citizens also may comment on housing and community development needs for future planning for the CDBG, HOME, and ESG programs. These comments will contribute to the development of the FFY 2025 Housing and Community Development Annual Action Plan.

The public hearing will be held at 7:00 p.m. in the City Commission Chambers located on the 9th floor of City Hall at 300 Monroe Avenue, NW.

Your COMMUNITY DEVELOPMENT COMMITTEE recommends adoption of the following resolution setting the date for a public hearing to obtain public comment on housing and community development program performance and needs.

3. That the City Clerk is directed to publish notice of said public hearing.
