The Grand Rapids Police Department (GRPD) recommends approval of the attached resolution authorizing payment to Grand Valley State University Police Academy for the tuition and expenses related to the certification of up to ten employees.

The process of hiring non-certified employees will broaden and increase the candidate pool of individuals that have a drive to serve the public. The recruit class will consist of up to ten individuals who will begin on April 28, 2025, and graduate on August 21, 2025. Complete cost of the training and certification for Recruit Class 25-02, funded through the Fiscal Year 2025 Police General Fund, is \$96,200. This includes tuition, student fees, and uniform expenses.
