SUBJECT: **Resolution approving an Encroachment Agreement with Mary Free Bed Medical Group Related to a Proposed Pedestrian Bridge for Encroachments in Wealthy Street SE**

The City has received a request from Mary Free Bed Rehabilitation Hospital, to encroach into the Wealthy Street right-of-way at 235 Wealthy St SE in connection with a pedestrian bridge and arch. On August 22, 2024 the City Planning Commission approved the Special Land Use and Site Plan Review request of Mary Free Bed Rehabilitation Hospital for the pedestrian bridge to connect the new three-story building under construction at 220 Wealthy Street to the existing patient tower at 320 Jefferson Ave SE.

The request has been circulated to affected City departments and there were no objections.

The attached resolution approves an Encroachment Agreement and authorizes the Mayor to execute said agreement on behalf of the City, contingent upon approval as to form by the City Attorney. The agreement will set forth the conditions under which the encroachment will be permitted, including requirements to remove the encroachment if requested by the City, to maintain appropriate insurance in the types and amounts determined by the City's Risk Manager, and to indemnify the City.

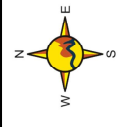
Proposed Vacation Area for Pedestrian Walkway and Archway
