This may include employer host agreements to meet their organizational requirements.

GRow1000 offers youth ages 15 to 24 the opportunity to explore a career and obtain valuable summer work experience. Program participants are matched with employers for a 6-week, 120-hour, paid work experience. Area businesses and organizations introduce youth to real-world work environments, provide mentorship, and create pathways to future careers. Program funding includes payments from employers hosting youth, donations from businesses and individuals, and philanthropic grants.

Although private funding has decreased, the City is committed to the program. In addition to paying for placements within our organization, other funds are used as available. For the 2025 program, the following funds will be used: 1) \$75,000 from the Grand Rapids Children's Fund, and 2) up to \$80,000 of Third Ward Equity funds to support enhanced participation by third-ward small businesses and youth residents.

Over the last five summers, 1,150 youth were employed at more than 70 unique job sites providing work experience at area businesses, colleges and universities, and nonprofit and government organizations. The 2025 goal is to employ 130 youth.
