SUBJECT: **Resolution approving an increase of \$164,979 for the Preventative Maintenance of Pearl Street Bridge over the Grand River, Burton Street Bridge over Grand Elk Railroad, and Hall Street Bridge over Grand Elk Railroad.**

On March 11, 2025 (Proceeding No. 94421), the City approved an agreement with Michigan Department of Transportation (MDOT) and authorized \$410,511 for the local share of expenditures with total expenditures not to exceed \$1,016,823. The project consists of preventative maintenance work on the Pearl Street bridge over the Grand River, Burton Street bridge over the Grand Elk Railroad, Hall Street bridge over the Grand Elk Railroad. The work includes substructure repairs, epoxy overlay, penetrating healer/sealer, silane treatment on bridge railing, concrete deck and sidewalk patching, concrete approach, curb and gutter and permanent pavement markings. Construction is anticipated to begin this Spring.

MDOT received bids for this project on March 7, 2025, after the March 11th agenda item that was based on the engineer's estimate had already been prepared. The engineer's estimate by Scott Civil Engineering Company (SCEC) is \$757,890 and Anlaan Corporation submitted a bid of \$1,196,662. Estimated total expenditures are \$1,532,820 which includes the MDOT grant and local share of project costs.

The attached resolution provides for the approval of an increase in the authorization of expenditures in the amount of \$164,979 for the local share of costs with total expenditures not to exceed \$1,532,820. This amount includes the construction contract, administration, contingency and previously authorized costs.

The project consists of preventative maintenance work on the Pearl Street bridge over the Grand River, Burton Street bridge over the Grand Elk Railroad, Hall Street bridge over the Grand Elk Railroad. The work includes substructure repairs, epoxy overlay, penetrating healer/sealer, silane treatment on bridge railing, concrete deck and sidewalk patching, concrete approach, curb and gutter and permanent pavement markings.
