SUBJECT: **Resolution recommending approval by the Michigan Liquor Control Commission of Social District Permit applications pursuant to Public Act 124 of 2020**

Public Act 124 of 2020 as amended empowers local communities to designate "Social Districts" containing "Commons Areas" where purchasers may consume alcoholic beverages sold by multiple qualified Michigan Liquor Control Commission (MLCC) licensees who obtain an MLCC Social District Permit. (Note: The Social District concept is distinct from, but may overlap with, permitted parklets and other outdoor seating areas.)

PA 124 specifies a 2-step process before a qualified licensee may use a Social District Permit:

1. City Commission designation of a Social District containing Commons Areas
2. City Commission recommendation of Social District Permit applications followed by MLCC issuance of Social District Permits

To date, the City Commission has designated eleven Social Districts: Downtown Grand Rapids, Wealthy Street, West Fulton, Creston, Fourth & Stocking, Michigan Street, West Leonard, East Fulton, East Hills, Cheshire Village, and Alger Heights.

The attached resolution recommends approval by MLCC of Social District Permit applications from the following MLCC qualified licensees, all located within the Downtown Grand Rapids Social District:

- a) Garden District Hospitality LLC; 55 Monroe Center St NW
- b) WB Blanton Enterprises, LLC dba Le Macaron; 132 Monroe Center St NW
- c) Nightwatch GR, LLC; 201 Fulton St W Unit 3

5. The licensed premises of the licensees are contiguous to the Commons Areas within the designated Social Districts; and
6. The City Commission desires to recommend approval of the Social District Permit application; therefore

1. That Social District Permit applications from the following licensees are recommended by the City Commission for consideration and approval by the Michigan Liquor Control Commission:
 - a) Garden District Hospitality LLC; 55 Monroe Center St NW
 - b) WB Blanton Enterprises, LLC dba Le Macaron; 132 Monroe Center St NW
 - c) Nightwatch GR, LLC; 201 Fulton St W Unit 3; and
2. That the City Clerk is authorized and directed to provide the applicants with a certification of this action in the form specified by the Michigan Liquor Control Commission.
